<u>Fire Reporting Cause Codes</u> – Revisited – Pat was contacted by Dianna Sampson of the Fire Reporting Subcommittee concerning the Fire Cause Codes. Her subcommittee needs for our committee to review and recommend an alternative system, if we didn't agree to the one that was proposed. As I understand it they would like us to re-review the proposal, with an open mind. Then if we don't agree provide her subcommittee with an alternative complete with definitions. There is a tasking being routed to us on this subject. See the attached proposed set of cause codes.

Previously we recommended preserving the existing nine cause codes, but did not develop the secondary causes and ignition factors. This is a discussion we will need to have at the annual meeting.
